Feasibility Study Started

The Florida Department of Transportation (FDOT) is beginning a Feasibility Study to evaluate the potential widening of North Jones Loop Road up to six lanes from CR 765 (Burnt Store Road) to Piper Road in Charlotte County, Florida. The project will include mobility, safety, intersection, emergency response, and evacuation improvements.



During the feasibility study, FDOT will collect input from the local community and public officials from Charlotte County and the City of Punta Gorda to establish the community's vision for North Jones Loop Road. This input will assist the FDOT in developing the project's purpose and need and establishing the initial feasibility alternative to meet the regional traffic needs and support economic development.

The study will investigate improvements with the goal to improve the regional transportation network and local mobility for commuters and freight truckers, evacuation and emergency responders, pedestrians and bicyclists.

The feasibility study will document the community's vision for the project and establish an initial project alternative that will be further developed and evaluated for environmental effects during the Project Development and Environment (PD&E) study phase.

How to Get Involved

A public information meeting is planned for the summer of 2021

to present the alternatives under consideration for your input. We will send a separate invitation to announce the meeting date and time. After the public information meeting, we will incorporate your input and document the results of the study.

The PD&E study phase is expected to begin in the fall of 2021 where a recommendation will be presented for your review and comment. At any time, you may provide your comments by contacting FDOT Project Manager, Richard (OJ) Oujevolk, P.E. His contact information is provided on the back of this flyer.

The environmental review, consultation, and other actions required by applicable federal environmental laws for this project are being, or have been, carried out by FDOT pursuant to 23 U.S.C. §327 and a Memorandum of Understanding dated December 14, 2016 and executed by the Federal Highway Administration and FDOT.
