The Florida Department of Transportation (FDOT) District One is proposing improvements on US 41. The project location is in Punta Gorda, Charlotte County. The project limits begin south of Payne Street and continue north past Rio Villa Drive.

This project will resurface the roadway and enhance bicyclist and pedestrian safety. Pedestrian features will be upgraded to be compliant with Americans with Disabilities Act (ADA) guidelines, and additional features will be upgraded or modified.

Proposed median modifications include closing some openings and converting others to directional openings. These changes will comply with access management standards.
