




## **Project Overview**

The Florida Department of Transportation's (FDOT) contractor, V&H Construction, begins work in August to add a 10-foot-wide asphalt shared use path on the northside of SR 80 from Shoreland Drive to Old Olga Road/Buckingham Road. An eight-foot-wide sidewalk will be constructed on the southside of SR 80 from Orange River Boulevard to Verandah Boulevard, from Parker Avenue to Upcohall Avenue and Weber Boulevard to Loring Way, tying existing sidewalk together.

The project includes bus shelter pads, curb and gutter, drainage improvements, lighting, and signal work.
