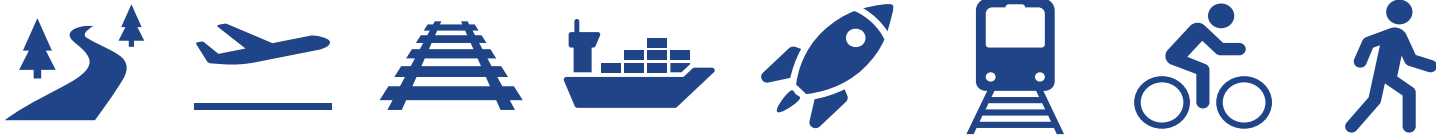

About FDOT District One

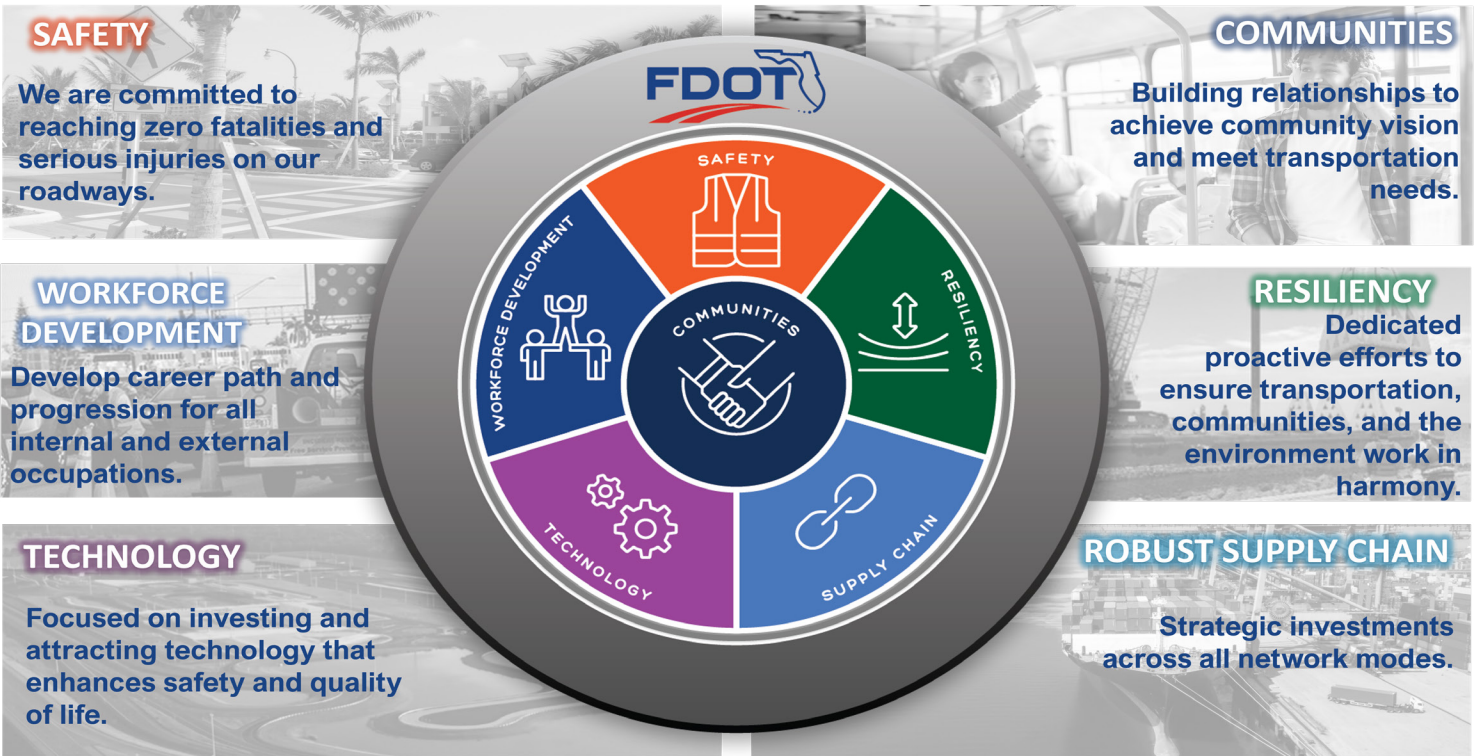

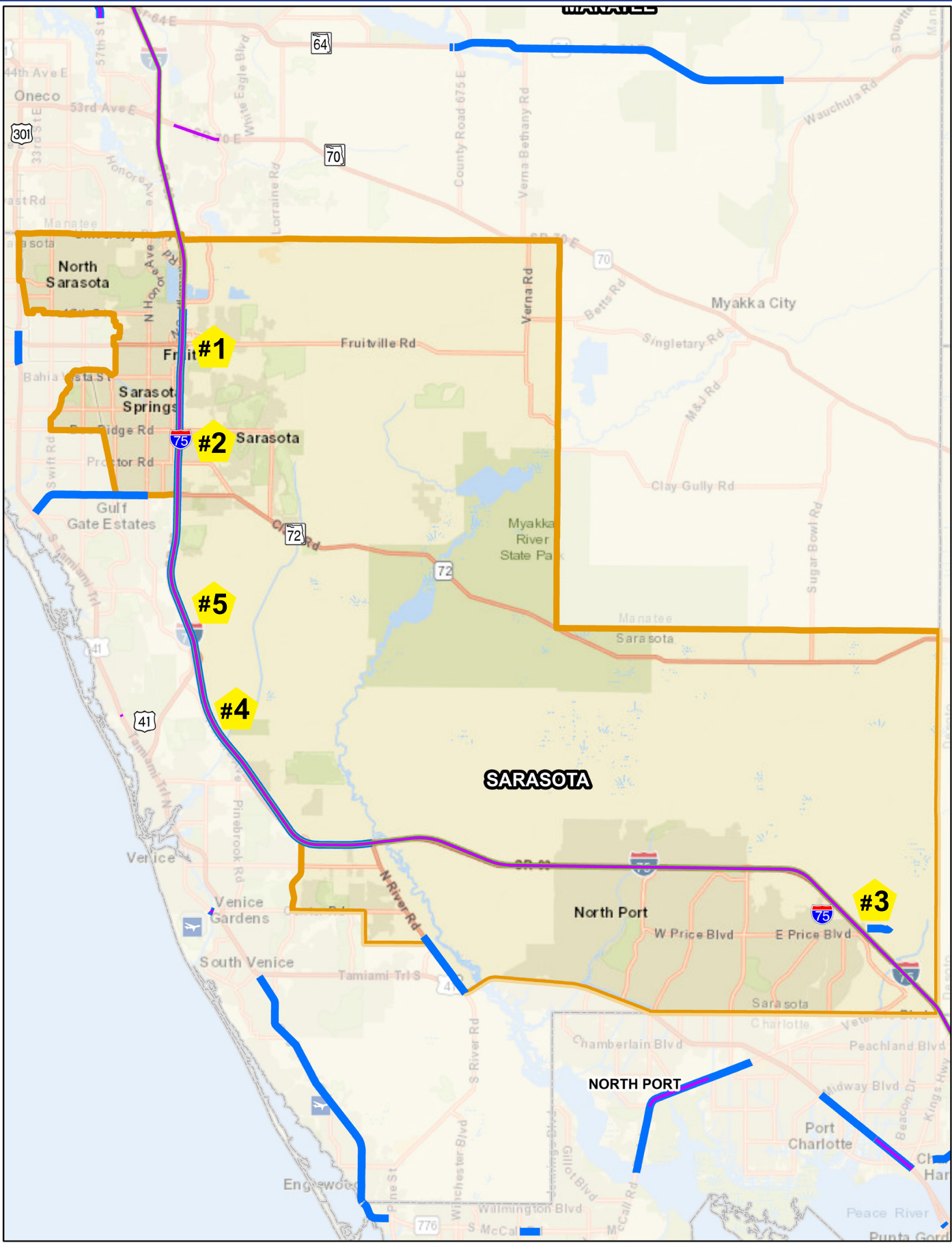

DISTRICT ONE PROJECTS OF INTEREST

PD&E STUDIES, DESIGN, and CONSTRUCTION

- Benefit and transform our communities by providing essential safety improvements for motorists, pedestrians, and cyclists to achieve Vision Zero
- Add capacity and traffic flow strategies to mitigate congestion for our travelers
- Design innovative intersections and roadways to modernize our roads; and, enhancing safety, mobility, and connectivity with new trails, bike lanes, and sidewalks.

#1: I-75 (SR 93) AT FRUITVILLE ROAD/CR 780

- FPID: 420613-2
- Construction – Will widen I-75 to a six-lane highway with three through lanes per direction, will replace existing bridges over Fruitville Road, and rebuild interchange from a partial cloverleaf to a diverging diamond interchange (DDI).
- FY 2027
- Total Cost: \$35,562

#2: I-75 (SR 93) AT BEE RIDGE ROAD

- FPID: 201277-5
- Construction - Interchange
- FY 2029
- Total Cost: \$5,380,196

#3: INKWOOD DR OVER LITTLE FIELD WATERWAY BRIDGE #175030

- FPID: 447255-1
- Construction – This project will replace the structurally deficient Bridge 175030 owned by the city of North Port.
- FY 2027
- Total Cost: \$3,215,005

RESURFACING PROJECTS

- Preserve, maintain, and enhance our system by extending the roadways’ lifetime
- Provide a smooth ride to reduce wear and tear on our vehicles
- Install safety measures which may include wider bike lanes, pedestrian crossing devices, and modified medians to protect our fellow roadway users
- Upgrade traffic signals with modern, smart equipment.

#4: I-75 (SR 93) FROM SR 777 TO SR 681

- FPID: 451734-1
- Resurfacing – Design Build
- FY 2026
- Total Cost: \$40,053,629

#5: I-75 (SR 93) FROM SR 681 TO SR 780

- FPID: 449188-1
- Resurfacing
- FY 2028
- Total Cost: \$37,814,413
