

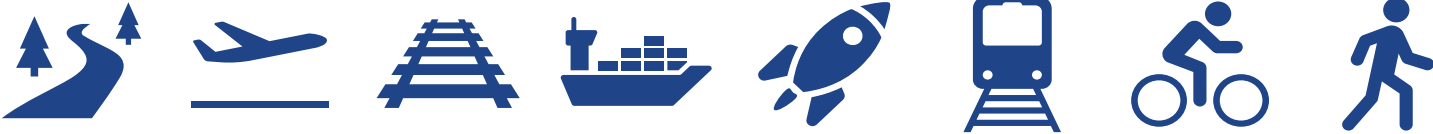

About FDOT District One

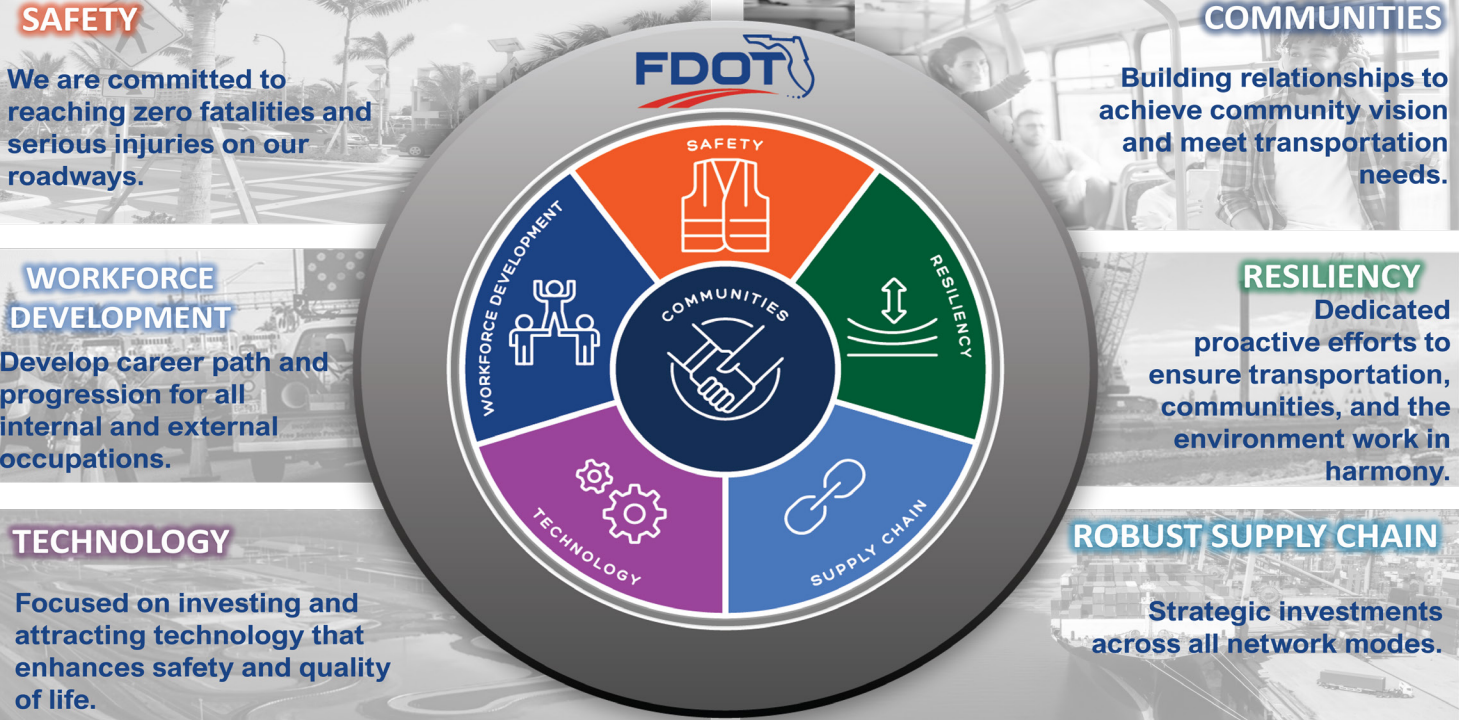

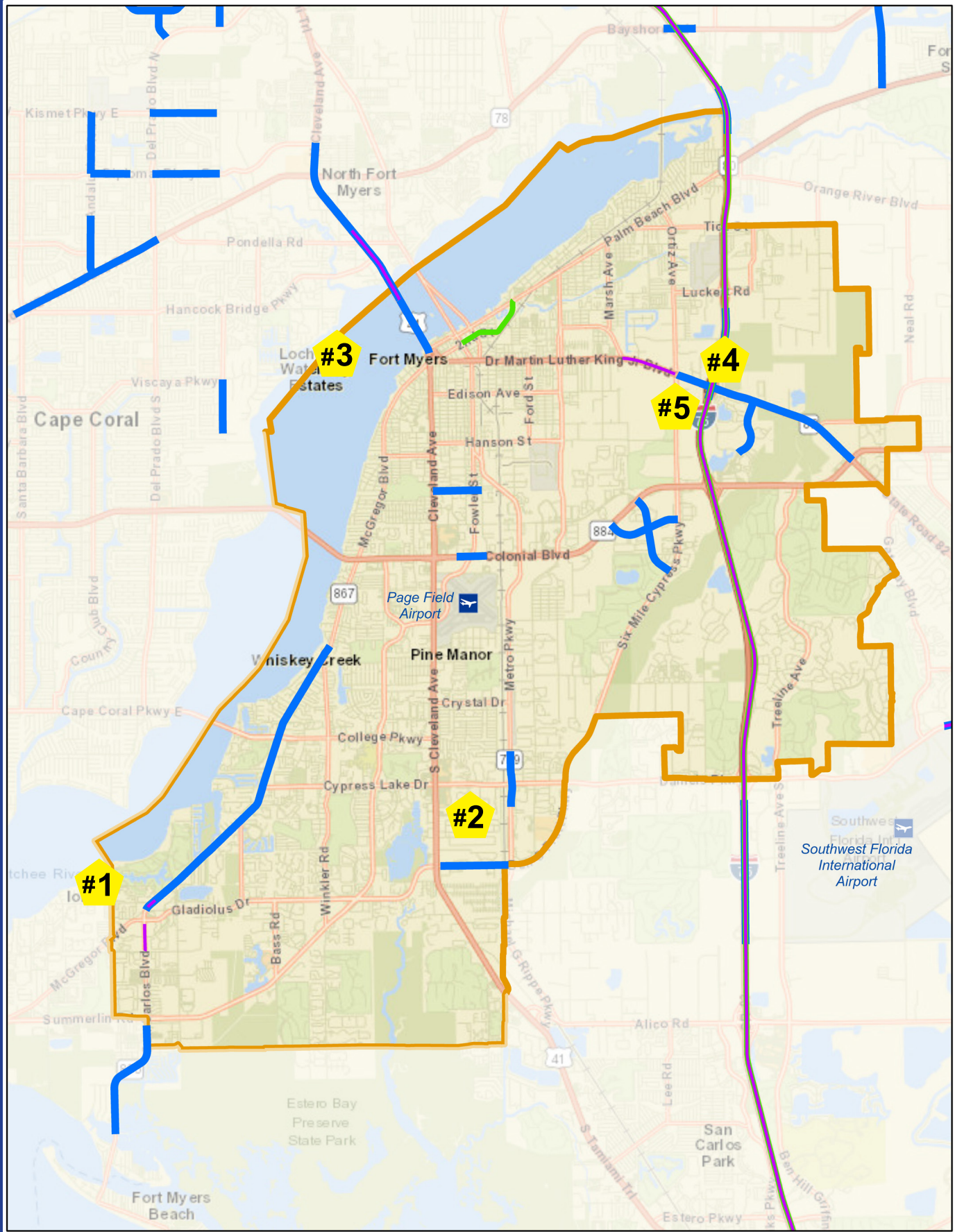

PD&E STUDIES, DESIGN, and CONSTRUCTION

- Benefit and transform our communities by providing essential safety improvements for motorists, pedestrians, and cyclists to achieve Vision Zero
- Add capacity and traffic flow strategies to mitigate congestion for our travelers
- Design innovative intersections and roadways to modernize our roads; and, enhancing safety, mobility, and connectivity with new trails, bike lanes, and sidewalks.

#1: MCGREGOR BLVD AT IONA DR INTERSECTION

- FPID: 448706-1
- Construction - This project would modify the median on McGregor Boulevard to provide the width needed to construct a southbound right turn lane.
- FY 2028
- Total Cost: \$2,224,843

#2: SR 739 (METRO PKWY) FROM S OF DANIELS PKWY TO N OF DANIELS PKWY

- FPID: 431334-2
- Construction – Construction of a Continuous Flow Intersection (CFI) with a series of three closely spaced intersections designed to add capacity, improve safety, reduce intersection delays.
- FY 2029
- Total Cost: \$53,522,031

#3: US 41 OVER CALOOSAHATCHEE RIVER BRIDGE #120002

- FPID: 451357-1
- Construction – This project includes spall repairs, crack injections and installing pile jackets on the substructure of the bridge to extend its service life.
- FY 2026
- Total Cost: \$1,260,448

RESURFACING PROJECTS

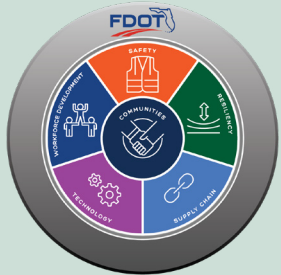
- Preserve, maintain, and enhance our system by extending the roadways' lifetime

- FPID: 448955
- Resurfacing - This project will resurface parts of SR 82.
- FY 2026
- Total Cost: \$12,661,251

#5: I-75 FROM S OF SR 82 TO S OF LUCKETT RD

- FPID: 453559-1
- Resurfacing and Other Improvements
- FY 2029
- Total Cost: \$7,944,890

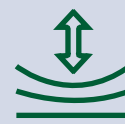
