#### **Operation Spring into Safety**

Through a partnership between the Florida Department of Transportation District One and the Lee County Sheriff's Office, the inaugural traffic safety



and touch-a-truck event was held at the Hertz Arena in Estero, Florida on April 13th.

Children of all ages had the opportunity to see, explore, and learn about more than 50 pieces of heavy equipment used to build roads and bridges, law enforcement vehicles including mobile command centers, police vehicles, helicopters, and emergency response vehicles such as ambulances and fire trucks.

In addition to the large construction and emergency response vehicles, attendees had the opportunity to talk with highway safety advocates and the children had the chance to test their bicycle safety skills at a Bike Rodeo.

More than 200 volunteers from 24 organizations helped ensure this event was a success. We thank you!

## **Internal Training: Active Shooter**

District One's Industrial Health and Safety Team coordinated Active Shooter training with local law enforcement partners at various locations throughout the District.

**Warning Signs.** One key objective of active shooter training is learn about warning signs that may precede an active shooter incident, such as aggressive behavior, threats of violence, or fascination with firearms. Early reporting of concerning behaviors can help prevent potential incidents before they escalate.

**How to Respond.** Another objective of active shooter training is teaching individuals how to respond if they find themselves in an active shooter situation. This typically involves the "Run, Hide, Fight" protocol, which is widely promoted by law enforcement agencies.

**Run.** Individuals should first attempt to escape the area if it is safe to do so.

**Hide.** If escape is not possible, they should find a secure place to hide, silence their phones, and barricade the door if possible.

**Fight.** As a last resort, individuals are encouraged to take action against the shooter, using any available objects as improvised weapons

**Be prepared.** While the hope is that no one will ever

have to use the skills learned in active shooter training, the reality is that being prepared can make a crucial difference in the outcome of such a situation. Active shooter training plays a vital role in enhancing safety by providing individuals with the knowledge, skills and mindset needed to respond effectively.

The Industrial Health & Safety Team also provides *Stop the Bleed* Tourniquet training. This training is key to stopping people from bleeding out from traumatic injuries such as stabbings, gunshot wounds, or work-related injuries.

# Pedestrian and Bicyclist Safety Efforts



ast year in Florida, 8,413 people were injured in a crash while riding a bicycle and of those 228 were killed. Over 10,000 people were injured while walking and 783 pedestrians were killed in crashes. (Source: Florida Highway Safety & Motor Vehicles)

Creating safer environments for pedestrians and cyclists is a priority for the District One Safety Office. One way to help reduce crashes involving pedestrians and bicyclists is the installation of Pedestrian Hybrid Beacons (PHBs). PHBs enhance pedestrian safety and reduce the number of crashes by providing a controlled crossing point at locations where Rectangular Rapid Flashing Beacons (RRFB) or traditional traffic signals may not be warranted. PHBs alert drivers to the presence of pedestrians or bicyclists, reducing the risk of crashes.

District One activated 12 PHBs throughout the district in 2023:

- Three (3) PHBs along US 41 in Collier County
- Three (3) PHBs at Gulfstream roundabout in Sarasota County
- Five (5) PHBs along Cleveland Ave in the City of Ft Myers, Lee County
- One (1) PHB at US 17 near
   Hyland Ave in City of Winter
   Haven, Polk County

#### **Did You Know?**

In a recent before-and-after study of the PHB signals on Cortez Road, the results showed a **63% decrease in fatal and serious injury crashes.** 

By changing the context, speeds, and feel for the roadway, ALL crashes were reduced by 20% on the corridor.

"Pedestrian Hybrid Beacons play a crucial role in creating safer streets for everyone," said Amy Ao, Bicyclist & Pedestrian Safety Specialist.

"By enhancing visibility and awareness, they contribute significantly to reducing crashes and promoting active transportation."

#### Will people cross at the PHBs?

Yes. During a 12-hour period, 624 people were observed crossing Cortez Rd. Of those, 41% of the people used the PHBs, and another 50% crossed at the signalized intersection. Only 9% crossed without using a marked or designated crossing location.

# FDOT Partners with Virginia Tech Transportation Institute SCRIM Testing

Through a Federal Highway Administration Pilot Program, the Virginia Tech Transportation Institute's SCRIM (Sideway-Force Coefficient Routine Investigation Machine) operated in District One to gather data. The SCRIM truck visited the Manatee Operations Center to demonstrate its advanced capabilities. This vehicle is a precise surface friction tester, essential for accurately measuring skidding resistance on wet roads.

The SCRIM effectively evaluates road safety by delivering crucial details on friction levels in challenging areas such as ramps, loops, curves, and super-elevated sections. These locations have historically posed challenges for conventional assessment methods. It enhances or supersedes traditional friction measurement tools, providing valuable insights into road departures, wet-weather crashes, and overall traffic performance.

By assessing skid resistance across different pavement types and surface treatments, the SCRIM plays a vital role in promoting safer road conditions.







### Benefits of the **SCRIM**

The SCRIM delivers accurate and objective measurements of skid resistance on wet surfaces, pinpointing areas with lower skid resistance that may be susceptible to crashes. Operating efficiently, the truck can cover distances ranging from 45 to 150 miles per tank of water, traveling at speeds between 15 to 55 mph without requiring traffic control.

During its operation in Sarasota and Manatee counties, the SCRIM collected 150 miles of GPS-linked data on friction and texture, along with detailed information on geometry (such as curves, grades, and crossfalls), and video footage.

This comprehensive dataset is invaluable for prioritizing maintenance efforts aimed at reducing crash risks, particularly in wet weather conditions.

District One public roadways also saw a reduction of FSI crashes at a rate of 0.013 per mile



However, along the District's Top 20 high crash corridors there was a significant reduction of 2.64 FSI crashes per mile per year or 113 fewer FSI crashes.

The significant reduction in FSI crashes can be attributed to the safety countermeasures implemented in the high crash corridors. For example, US 41 in Manatee County, was identified as one of the high crash corridors with **D1 Top 20 Corridors Compared to State and District**


### **Helmet Fitting**



The event was started in 2022 by a group of students after a fatal crash involving a high school bicyclist.


This year, the event was held on the school football field, where vendors were set up and there was plenty of space for a bike rodeo.

# **Destination Zero Roadway Safety Forum**

District One Safety Administrator Keith Robbins and John Kubicki, Safety Work Program Manager, spoke at the Destination Zero Roadway Safety Forum hosted by the Sarasota/Manatee Metropolitan Planning Organization (MPO) on May 23.

Attendees learned about the key strategies of traffic safety, crash data trends statewide and for the local area, Target Zero initiatives, and District One Safety initiatives. Some of the safety projects highlighed included:

- Roundabout at SR 64 and Rye Rd.
- Pedestrian Hybrid Beacons
- Speed Management on US 41



A second public meeting was held in Manatee County to discuss safety improvement projects along SR 55 (US 19) and 11th Ave intersection.

The proposed improvements include converting the existing full median opening to a directional median opening and will prevent left turns from 11th Ave onto SR 55.

By preventing left turns, the diectional median opening will eliminate safety concerns as well as provide a pedestrian refuge in the media for those looking to cross the road.

Whether it is for traffic stops or tactical operations, these devices will play a crucial role in enhancing the safety of law enforcement partners.






# Polk County Geofencing Campaign with Sheriff Grady Judd

Maybe you have seen him in his bright vest and brighter smile at a partner outreach and education event! Or it may have been on the side of the road testing the Pedestrian Hybrid Beacon (PHB) or Rectangular Rapid Flashing Beacon (RRFB) equipment.

With his background, and several certifications, including with the International Municipal Signal Association, he was a perfect fit to take the lead on the Polk County Speed Feedback Sign pilot program. Speed feedback signs were installed at multiple locations in



Polk County to assist with speed control efforts and targeted law enforcement. While still a work in progress, this project led him to be involved in evaluating, installing, and maintaining speed feedback sign equipment across the District. No matter where he is or what his assignment, his enthusiasm is infectious.

# Partnering with Local Agencies to Improve Lighting

In 2022, nighttime crashes accounted for 41% of the fatal crashes in District One. Last year, District One Safety purchased over 1,250 light fixtures which were installed by our maintaining agencies. This year, over 780 light fixtures have already been purchased. Sarasota County, City of Sarasota, Manatee

County, and Hendry County were major contributors.

The post-installation study shows a 32% reduction in fatal and serious injury crashes.

This initiative highlights how local agencies that are willing and able to partner with FDOT can make improvements on our roadways that can enhance the safety for all users.

#### **OPERATION SOUTHERN SLOWDOWN**



Operation Southern Slow Down is a week-long speed enforcement and education campaign conducted between July 15–29.

State troopers and local law enforcement officers will conduct concentrated enforcement on interstates and state highways in the Southeast (Florida, Alabama, Georgia, South Carolina,

and Tennessee) for the week in a team effort to help prevent an increase in

drivers traveling at speeds well above the legal limit.

Operation Southern Slow Down" began in 2017 when these five states that comprise National Highway Traffic Safety Administration (NHTSA) Region 4 – Florida, Alabama, Georgia, South Carolina, and Tennessee – decided to hold a week-long joint speed enforcement and education awareness campaign annually in the third week of July with the goal of reducing crashes and saving live

Three Professional Engineer Trainees spent a week in the Safety Office in June as part of Florida Department of Transportation's Professional Engineer (PE) program. The PE program is a four-year, two-phase training program encompassing all aspects of the Department's operations, including Safety, leading to licensure as a Professional Engineer.

"It has been an invaluable experience spending time and learning from the Safety team," said Leonida Culbreth. "I was surprised to learn about the comprehensive nature of safety protocols including the detailed analysis of Crash Modification Factors (CMF) and their impact on countermeasures."

"The integration of GIS data in crash analysis was an eyeopener," explained Leonida.

The PE Trainees received an overview of the Safety Office from Dr. Keith Robbins, Safety Administrator, and then they spent time with the three sections of the Safety Office: Industrial Health and Safety, Traffic Safety Outreach & Education, and Safety Work Program.

### **Community Traffic Safety Teams in ACTION**

#### **Glades County**

Glades County requested the installation of several guide signs to alert motorists to the location of the Sheriff's Office and the Emergency Management & Fire Station near the intersection of US 27 and SR 78.

District One sent plans for the Glades County staff for review in February 2024 and the signs wer installed in March and April.







#### **Hardee County**

Law Enforcement partners in Hardee County alerted the CTST to concerns with wrong-way drivers exiting Ranch 17, an event venue in Wauchula on SB US 17 south of Sterner Rd. (06010102 around MP 3.2). They asked FDOT to post Wrong Way/Do Not Enter signs just north of the driveway to the venue or add signage indicating no right turn at the driveway or across the street where the one-way sign is posted.

Plans were developed to install wrong way/do not enter signs in both north and south bound directions.

Peace River Operations crew installed the signs in March 2024.

#### **Glades County**

While there is a planned project to resurface CR 74 in Glades County from Firetower Rd. to SR 29 as part of a local area partnership, work will not be completed until FY 2026.

Glades County Sheriff's Office had been receiving calls since the beginning of 2024 from drivers asking for assistance with flat tires or waiting for tow trucks in this area. Officers noted many spots where the pavement conditions had already failed.

Glades County and LaBelle Operations worked together to patch several of the worst spots. These patches will make the road safer until the resurfacing project comes through the area.



#### **Glades County**

After a fatal crash damaged the reflective signage at the terminus of CR 74 at SR 29 in Glades County in 2023, members of the Glades County CTST requested additional signing and pavement markings at this intersection.

Traffic Services installed yellow skip lines, double yellow signs, white stop messaging, a new arrow sign with embedded LED/reflector, and a stop sign flasher. These types of low-cost safety countermeasures increase driver awareness and recognition of intersections and potential conflicts.





#### **HighlandsCounty**



Highlands County School Transportation reported multiple incidents of motorists speeding past bus stop arms on US 27. Initially, Law Enforcement responded by monitoring US 27 at Stephens Dr, Lake Ridge Dr., and Hickory Ln. However, a more permanent system was requested.

Through a partnership with Highlands County, FDOT installed advanced warning signs with flashers in Spring 2024. Maintenance and control were transferred to the County, and will be active during the 2024-2025 school year.
