PUBLIC NOTICE

On July 25, 2025, the Florida Department of Transportation (FDOT) Office of Environmental Management (OEM) granted Location and Design Concept Acceptance for the US 41 (SR 45) at Bonita Beach Road Project Development & Environment (PD&E) Study in Lee County. The proposed improvements consist of modifying the US 41 and Bonita Beach Road signalized intersection to be a partial displaced left turn, with the northbound and southbound left turn movements crossing over to be outside the opposing traffic flow. This configuration will allow the northbound and southbound left turning movements to operate in the same signal phase or simultaneously as the northbound and southbound through movements. As part of the intersection improvement, a new northeast quadrant roadway connecting US 41 to Arroyal Road will be provided. Throughout the intersection area, a 12-foot-wide shared use path will be provided.

Approval of the recommended alternative is the result of the PD&E study that evaluated various alternatives for the US 41 at Bonita Beach Road intersection including an overpass alternative and the no-build alternative. The study included engineering and environmental analysis, a public involvement program and inter-agency coordination.
