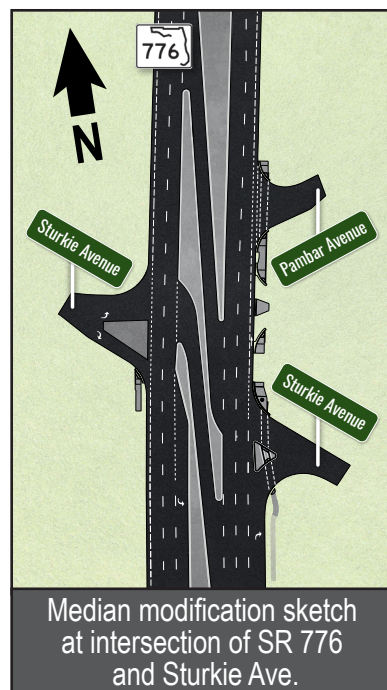
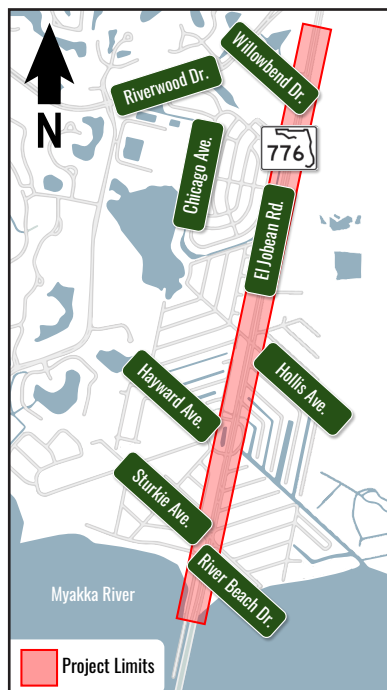

## Project Overview



The project is located along SR 776 between the Myakka River Bridge and Willowbend Drive in unincorporated northwestern Charlotte County. The approximately 1.7-mile project corridor will consist of milling and resurfacing the pavement to extend the life of the existing roadway.

Due to the high rate of crashes at the intersection of SR 776 and Sturkie Ave., the present median opening will be converted to a directional median opening with a left turn lane in both the northbound and southbound directions. This will prevent the left-out movements from Sturkie Ave. and Pambar Ave. onto SR 776. The median at Pambar Ave. will be closed, and the side street will have right in/right out access.


Additional project elements include ADA improvements and replacement of existing signage and damaged drainage structures. All improvements will occur within the existing right-of-way.

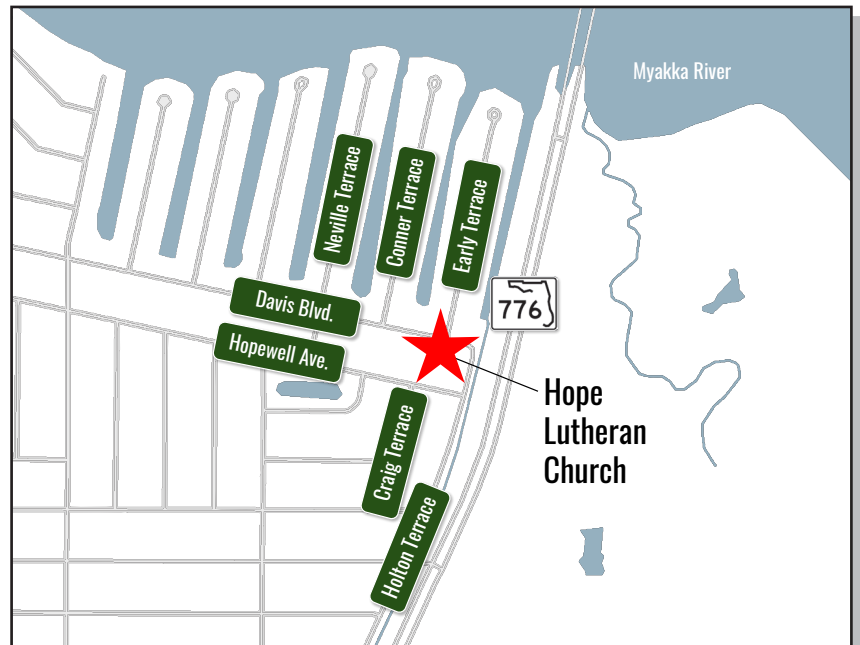
