

The project includes median modifications along US 27 at: North Lake Damon Road Ponce De Leon Boulevard Whisper Circle Lake Josephine Drive Lake Francis Road



•Areas where paths legally cross within an intersection

- •Reducing the number of conflict points increases safety
- •Restricted Crossing U-turn 54% reduction fatal/injury crashes




### US 27 at North Lake Damon Road






