Project Information

The Florida Department of Transportation (FDOT) is conducting a Project Development and Environment (PD&E) Study on State Road (S.R.) 70 from West of S.R. 31 to SE Highlands County Line Road in DeSoto County. The intent is to improve traffic safety conditions on S.R. 70, maintain important east-west connectivity within the regional transportation network, and accommodate freight activity within the area. The study will evaluate the widening of S.R. 70 from a two-lane undivided roadway to a four-lane divided roadway, including operational improvements from west of S.R. 31 to SE Highlands County Line Road. The project length is 16.7 miles.

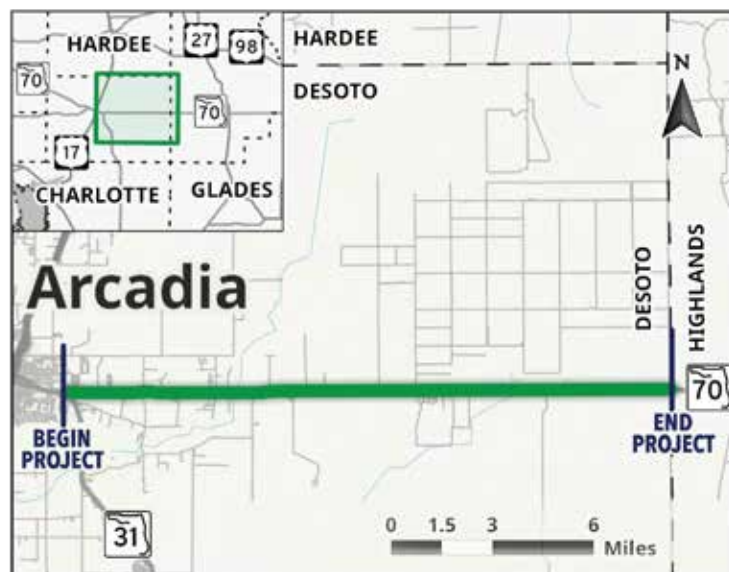
About the Project

To accomplish the roadway widening, the project proposes to construct two new travel lanes predominantly on the north side of the existing two travel lanes. The existing two lanes will stay close to their current alignment, and both become east bound travel lanes. The proposed new west bound lanes will be two new travel lanes constructed on the north side of the existing lanes.

In addition to the new travel lanes, the project proposes five new bridges and two bridge replacements, all with accommodations to allow safe wildlife crossings across the corridor at the bridge locations. A new pedestrian underpass is also proposed at the Joshua Creek bridge, to further improve accessibility and safety for non-motorized users.

The proposed project will remove a portion of the Old S.R. 18/Mahon Avenue (ODE00828) linear path along S.R. 70, which is eligible for the National Register of Historic Places. While this will impact the historic resource, its previous function will be documented and the recreational function replaced by a new shared-use path throughout the entire project limits.
