About the Projects

These design projects are part of a broader FDOT initiative to improve the S.R. 29 Immokalee corridor, which has been underway since 2007. Design for the new alignment of S.R. 29 around downtown Immokalee—from C.R. 846 East to S.R. 82 in Collier County—began in May 2018. The PD&E phase was completed on June 19, 2024, and the most recent public project update was shared in May 2024.


417540-5: From C.R. 846 E to North of New Market Road N

This segment of S.R. 29 is a new alignment and will feature a divided roadway, speed limits between 45 to 55 miles per hour, shared use paths on both sides of the road, pedestrian-activated signals at the C.R. 856 and Alachua roundabouts, and a signalized intersection at the existing S.R. 29 and new S.R. 29 alignment location.

417540-6: From New Market Road to S.R. 82

This segment of S.R. 29 is being widened from 2 to 4 lanes and will feature a divided roadway, speed limits between 45 and 55 miles per hour, shared use paths on both sides of the road, and pedestrian-activated signals at the New Market Road/Westclox Road roundabout.

Both project alignments were selected based on the result of a series of analyses which included several public meetings, hearings, technical evaluations and stakeholder coordination.
