#### **PROJECT OVERVIEW**

The Florida Department of Transportation (FDOT), District One, is conducting a Project Development and Environment (PD&E) Study for proposed improvements to the State Road (SR) 70 corridor in Okeechobee County. The project limits extend from NW 128th Avenue (CR 599) to US 98, a distance of 6.9 miles. The project's purpose is to address traffic safety conditions, including emergency evacuation and incident response times. Other project goals include maintaining important east-west connectivity within the regional transportation network to accommodate freight activity.

#### WHAT IS A PD&E STUDY?


A PD&E Study is the formal process of developing and comparing alternatives against a defined project purpose and need, to determine a preferred action that meets project goals while minimizing impacts on social, cultural, natural, and physical resources. Engaging the public by sharing and receiving information is a key component of this process and is required by the National Environmental Policy Act.

#### WHAT CAN YOU EXPECT?

As part of the PD&E process, FDOT alternatives will be evaluated to determine social and environmental impacts, safety enhancements, additional right-of-way, and traffic performance. Currently, alternatives under consideration include widening SR 70 from a two-lane undivided roadway to a four-lane divided roadway with multimodal facilities, such as a shared-use path, along the project segment.

Throughout this process, FDOT will consider a "no-build" option, which assumes no improvements to SR 70 other than routine maintenance. If the study results in the selection of a "build" alternative, the project can proceed to a design phase, for preparation of construction plans.

As part of the study kickoff, we invite you to participate. As the study progresses, we will use the input we receive from the community to refine alternatives. 

#### **PROJECT SCHEDULE**

Initial activities include collecting data, developing alignment alternatives, and evaluating potential social and environmental effects of the alternatives. The project team will present these alternatives at an alternatives public meeting, tentatively scheduled for summer 2026. A formal public hearing is tentatively scheduled for late 2027. You will receive notifications through the mail prior to each meeting. After the public hearing, FDOT District One will submit project documents to the FDOT Office of Environmental Management for Location and Design Concept Acceptance.
