


- •Crash data from 2015–2025 shows safety concerns at Gulf Park Drive and Ridge Drive.
- •At Gulf Park Drive, about 20% of crashes could have been prevented with the proposed median modification.
- •At Ridge Drive, 33% of crashes could have been prevented with the proposed median modification.
- •These improvements will reduce conflict points and enhance safety along US 41.




Restricting the number of conflict points reduces fatal and injury crashes by **54**%


Existing Condition: Gulf Park Drive
