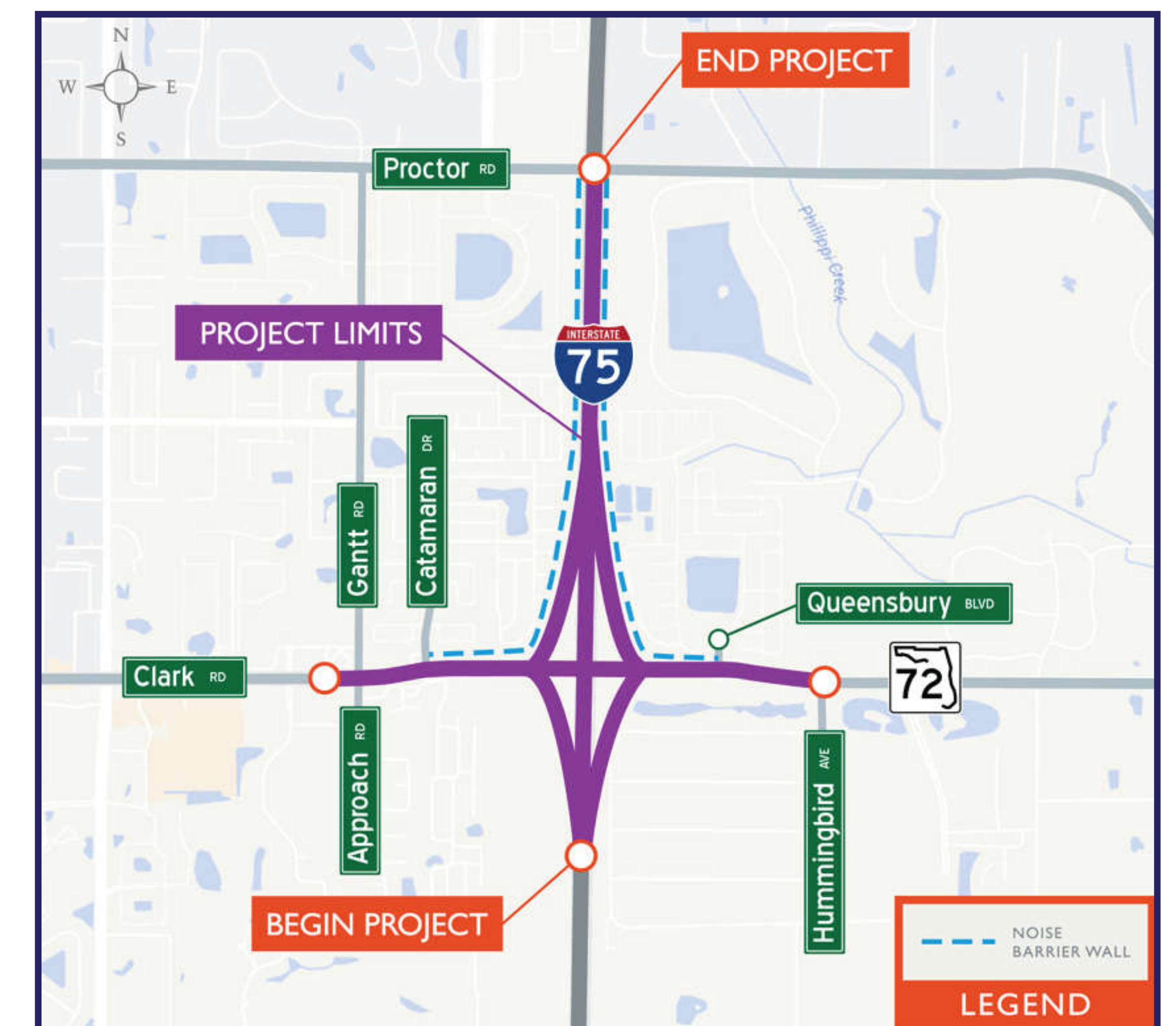

Stage III

Early/Mid 2023

Final resurfacing and striping
Open DDI

TIPS FOR ROAD USERS

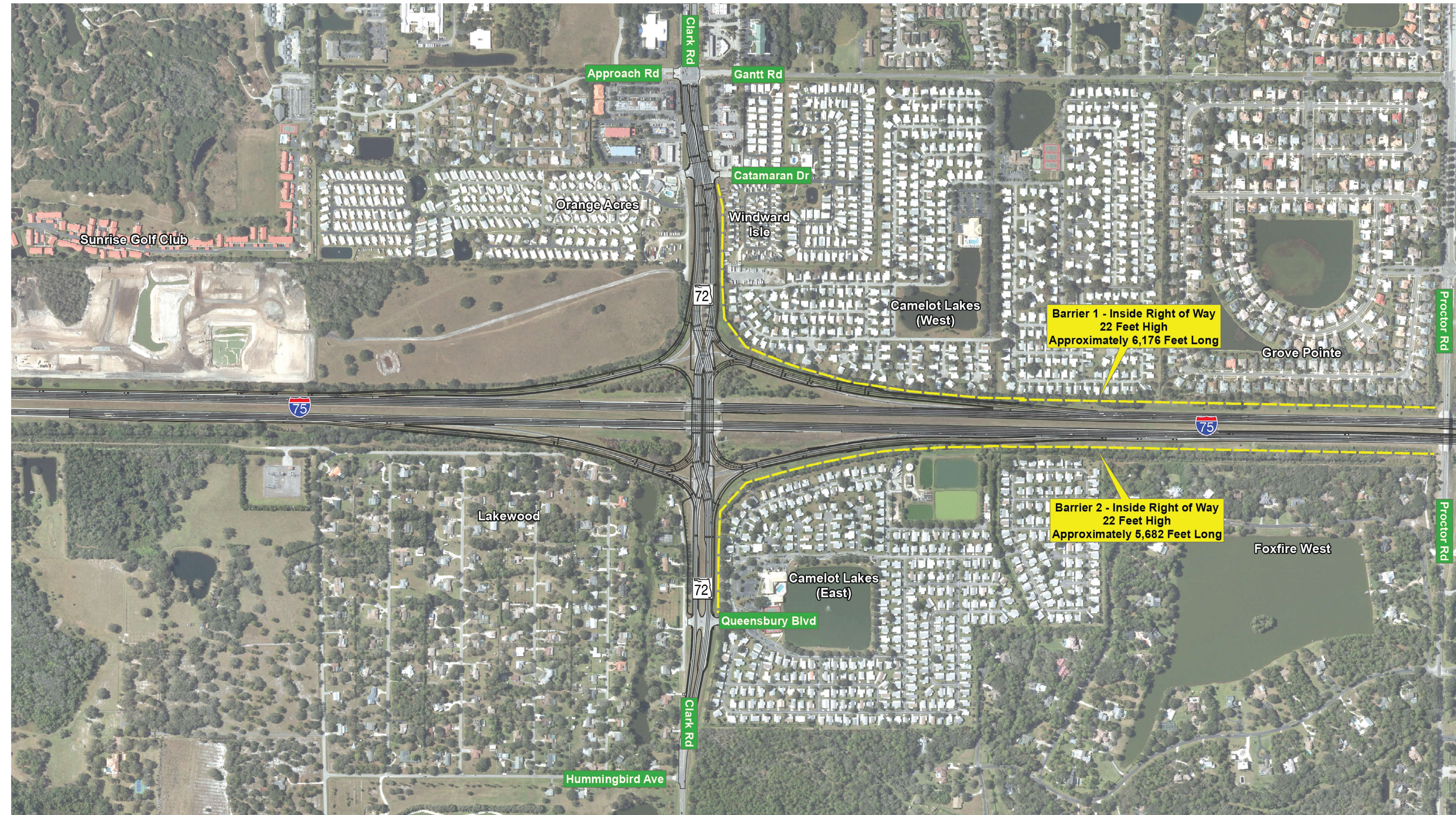
- **WATCH**
