## US 41 from East of SR 84/Davis Boulevard to Courthouse Shadows Pedestrian Safety Improvement Project in Collier County

### CONSTRUCTION PROJECT

The Florida Department of Transportation's contractor, Roadway Construction, LLC will begin work in early December to conduct pedestrian safety improvements on US 41 from east of SR 84/Davis Boulevard to Courthouse Shadows. The improvements include adding mid-block crossings and pedestrian signals, milling and resurfacing, and sidewalk within the project limits. The project area is identified on the project location map below. The construction will take place Sunday through Friday during daytime and nighttime/overnight hours, weather permitting. Lane closures will occur on US 41 during nighttime/overnight hours from 10 p.m. to 7 a.m.

### PROJECT IMPROVEMENTS

- Milling and resurfacing
- Addition of mid-block crossings
- Pedestrian signals at mid-block crossings

### PROJECT SCHEDULE

- Construction begins in early December 2021
- Expected completion date is late Fall 2022
- Construction cost is \$5 million

- Crews will be working during daytime and nighttime/overnight hours
