



GET INVOLVED TODAY!

The Florida Department of Transportation (FDOT), District One, on behalf of Manatee County, is conducting a Project Development and Environment (PD&E) Study for a proposed trail network within the City of Palmetto and Manatee County. This network will bring three key benefits to the community: 1) extend the reach of the existing Dr. Martin Luther King, Jr. Trail; 2) provide better connections that enhance safety between and among important community resources such as the MCAT Transit Station, Palmetto Youth Center, Lincoln Park and Washington Park (now under construction); and 3) help restore the Lincoln Tunnel to its former glory and provide safe and comfortable access to Lincoln Park and Lincoln Memorial Middle School.



With these community benefits in mind, our project team met with focus groups within the study area this past spring to gain input to shape an initial trail study network, particularly in the areas north of 17th Street. We now invite you to access a quick online questionnaire and other related information, maps, and updates by scanning the QR code or accessing the project website.







LEARN MORE ABOUT THE NETWORK

The Palmetto Trails network is part of a RAISE Grant application (previously BUILD Grant) initiated by the County and civic leadership. The depicted alignment will connect Washington Park, currently under construction since its groundbreaking on July 28, 2021, to Lincoln Park, which is undergoing renovations for additional and improved facilities since its groundbreaking on November 19, 2020. The Lincoln Tunnel is another prominent feature of the network which connects important destinations along the trail. The tunnel's background is an important part of the community's history and this project will study ways to restore it in commemoration of this history.
