## **PROJECT OVERVIEW**


The FDOT, District One, on behalf of Manatee County, has been conducting a PD&E Study for a proposed trail network within the City of Palmetto and Manatee County. This network will bring three key benefits to the community: 1) extend the reach of the existing Dr. Martin Luther King, Jr. Trail; 2) provide better connections that enhance safety between and among important community resources such as the MCAT Transit Station, Palmetto Youth Center, Lincoln Park, and Washington Park (now under construction); and 3) help restore the Lincoln Tunnel to its former glory and provide safe and comfortable access to Lincoln Park and Lincoln Memorial Middle School.

The workshop is being held to present information about the preliminary alternatives and provide the opportunity for the public to offer feedback. The FDOT will accept written comments during and after the workshop.
